As the Chair, I am eagerly looking forward to the changes she plans to implement to propel OBVS forward, which will be further discussed as the Board develops a new Strategic Plan.

Recently, we received two early resignations from Board members for personal reasons. Yuka Sugar joined the Board to replace our first 'early retirement' member; as a short-term replacement, she will run for office to continue as a full-term board member. 2023-2024 FINANCIALS

Financial Reports Review By James Holland

SUMMARY

Thanks to the unwavering support of our dedicated funders, OBVS experienced yet another successful fiscal year in 2023-2024. The year began with a budget of \$377,200, backed by a fund development goal of \$303,852, an increase of 5% compared to the previous year.

At the close of the fiscal year, our total expenditure amounted to approximately \$355,000, which was \$22,200 lower than projected. Meanwhile, our revenue reached around \$340,000, exceeding expectations by \$36,000. This surplus of over \$58,000 enables us to continue providing support and investing in the growth of our operations.

KEY DRIVERS

On reviewing spending trends, notable changes include a significant rise in staffing costs compared to the previous year. This increase can be largely attributed to the extended absence of one of our full-time team members throughout 2022, which necessitated hiring an interim team member to cover their responsibilities in 2023-2024.

Additionally, administrative costs experienced a surge due to executive leadership turnover and associated marketing expenses. These figures were further influenced by certain one-time professional service fees incurred during the year. In contrast, our Information and Technology costs decreased considerably from the previous year, as additional funds had been allocated in 2022 to support the development of our data management software.

Aside from minor increases to accommodate anticipated annual inflation, our Staff Development budget saw a notable boost. This rise was prompted by new leadership, encouraging the team to take full advantage of the Professional Development funding allocated to them. These funds empower our team members by facilitating continuous learning, the acquisition of new skills and connections, and the preservation of their unwavering dedication to community action.

A final figure not reflected in this financial report is \$156,280, representing the monetary value of over 7,200 hours of volunteer time that made this year possible. We cannot adequately express our gratitude for each and every individual who selflessly contributed their time, money, and heartfelt efforts throughout the past year.









2023-2024 Spending vs. 2020-2023 Spending




